MACOG & Transpo Propose Network Changes in CONNECT Draft Recommendations Report

South Bend, IN - Are we willing to pay for transit access that can transform people's lives and the quality of place? The Michiana Area Council of Governments (MACOG) and the South Bend Public Transportation Corporation (Transpo) want the community to help decide if the draft recommendations make transit more useful by responding to the **two funding scenarios** that result in short-term improvements and future investments.

The **short-term network** depicts key changes to improve service in South Bend, Mishawaka, Elkhart and Goshen based on the existing budget, while the **additional funding network** shows transformative regional access through a higher level of investment in transit.

With the release of the CONNECT Transit Plan's **Draft Recommendations Report**, MACOG and Transpo are entering the final round of public conversation in the development of the 10-year plan for transit in the region.

MACOG Executive Director James Turnwald said, "By prioritizing ridership across the region, both the Interurban Trolley and Transpo would serve more people and businesses benefiting from greater access, higher frequency and less waiting along key routes. The CONNECT Transit Plan's draft recommendations provide a roadmap of how best to optimize the current networks and transform the system over time. The report also identifies other critical gaps, like the lack of job access to manufacturing centers located outside the city proper. Vanpooling could be a stopgap measure deployed by MACOG to assist employers and industrial workers with fleet vehicles driven by employees who share rides to and from work."







"The Short-Term Transpo Network proposes increasing ridership by simplifying or extending routes and increasing or decreasing bus frequency using existing resources. With no additional budget for service, it would be impossible to add significant new hours of service, or Sunday service, without major cuts to route coverage or frequency of service." said Transpo General Manager & CEO, Amy Hill. "Looking ahead, the Additional Funding Transpo Network would provide transit service seven days a week and reach new areas of South Bend and Mishawaka currently not accessible by bus."

Over the next two months, MACOG and Transpo invite the public to learn more about these key recommendations by reading the report, coming to a public meeting, visiting with staff at major bus stops, and taking the public survey (available at the project website). The study team will be engaging the public in multiple ways from December 1 through February 7 to get responses from riders and the general public.
